

CONDITIONS FOR USE OF SPA

THE SPA TREATMENT MAY AFFECT DIFFERENT INDIVIDUELS IN DIFFERENT WAYS AND WE INVITE YOU TO BE PRUDENT.

PREGNANT WOMEN, DIABETICS, THOSE SUFFERING FROM CARDIOVASCULAR PROBLEMS, HYPERTENSION OR HIGH BLOOD PRESSURE, IN POOR HEALTH OR RECEIVING MEDICAL TREATMENTS SHOULD CONSULT THEIR DOCTOR BEFORE USING A SPA;

DURING PREGNANCY, IMMERSION IN HOT WATER FOR PROLONGED PERIODS OF TIME MAY HARM THE FOETUS.

<u>UNDER NO CIRCUMSTANCES SHOULD THE WATER TEMPERATURE EXCEED 38 DEGREES CELCIUS</u>

HYGIENE AND SAFETY RULES

Do not sit on the spa cover (danger of injury and damage) .

- 1. The spa is intended for **2 people** for a cycle of 20 minutes maximum. It is STRONGLY advised that the spa should not be used alone.
- 2. It is advised not to bathe with valuable objects. We decline all responsability in the case of physical or material dammage, loss, theft or alteration.
- 3. Hygiene The SPA is subject to a water treatment with chlorine.
- Shower beforehand with soapy water in order to remove all traces of moisturising creams, sun creams and dirt.
- Long hair should be tied up.
- Bathing suits and appropriate behaviour are required.
- Only swimming suits are authorised.
- It is strongly recommended you shower when leaving the spa and moisturise your skin.

4. Forbidden in the SPA:

- Cigarettes, electronic cigarettes, chewing gum, food, drinks, radios, telephones and other electrical devices.
- Loose or baggy clothing.
- Creams and oils.
- 5.Do not use the SPA in the case of open cuts or wounds, verrucas etc.
- **6.** Danger of drowning: leave the SPA immediately if you feel unwell, dizzy or sleepy. Hot water can cause overheating and loss of consciousness. The use of the SPA under the influence of alcohol, drugs or medication may cause a loss of consciousness.
- 7. For hygiene reasons, the cover should be replaced after every use.
- 8.A deposit of 500€ is payable at the beginning of your stay by cheque or credit card...

We regularly check the quality of the water. If a change of water is necessary for hygiene reasons, please note that 12 hours are necessary before the spa can be used again.

For any damage which might occur, the cost of repairs to return the SPA to its' original condition, or for the replacement of the damaged items by identical parts, by a qualified professional, to be chosen by « Theven » will be invoiced, in addition to the loss of revenue caused by said damage, or the water which has become unfit, from the day of said damage to the day the SPA is operational and fit for use. In this case, the payment of the invoice shall be made as soon as the amount is calculated, by the cashing of the 500 Euro deposit, if sufficient. If this amount is insufficient, the client may contact their insurers in order to recuperate their costs. In this case, they must pay the invoice sent to them by « Theven » within the stated deadline, and it is their responsibility to obtain reimboursement according to the conditions of their insurance contract.
